6	Course Description
	<p><b>Overview</b></p> <p>The PGCert Medical Ultrasound (Preceptorship) course has been designed to support students who have recently graduated from a BSc (Hons) Medical Ultrasound programme and are starting their journey as newly qualified sonographers. The course intention is to support you in developing your ultrasound skills and knowledge to work independently and within a defined scope of practice. Preceptorship is the transition from being newly qualified sonographer to being an autonomous, independent healthcare professional and includes the development of your transferable skills such as leadership.</p> <p><b>What's covered in the course?</b></p> <p>The preceptorship in medical ultrasound module is designed to extend your current skills and knowledge to enable to you to work independently as a thinking, practitioner sonographer. Once employed and working as a newly qualified sonographer in a clinical department you will be consolidating your scanning skills, whilst critically reflecting on the role of the Sonographer within the context of the NHS, and the role you play within the management of the patient as part of a multidisciplinary pathway.</p> <p>You will continue to develop skills in advanced communication and dealing with difficult situations, especially (for example) when it is necessary to break bad news. You will further learn about the governance aspects of ultrasound and how these should be managed. You will look at professional aspects such as dealing with complex patients, safeguarding and when duty of candour should be applied.</p> <p>You will also develop your understanding of skills which are used to develop services such as clinical audit, service commissioning and the requirements for meeting national targets for waiting times and how this can impact on clinical departments.</p> <p>Within your role as a newly qualified sonographer it is also important to not only further develop your independent learning and advanced scholarship skills to support your continuing professional development but also to help you develop the skills to interrogate the evidence that underpins your clinical practice. This will help you develop your confidence and autonomy, as well as developing your leadership skills. Given the infancy of the graduate BSc Hons Medical Ultrasound sonographer, development of these skills will be core to furthering your career within the ultrasound Career Framework.</p>

	<p>You will be supported by the clinical teams within the departments you are employed as well as by the university, who will work in conjunction with the departments to ensure that this course will support you as you develop yourself as a graduate sonographer.</p> <p><b>Learning and Teaching</b></p> <p>You will predominantly be continuing your learning within your clinical ultrasound department. Lectures and clinical workshops are designed to give you the opportunity to develop confidence and knowledge in a practical and informative way which will be related to your experience within the clinical department.</p> <p>Teaching will be delivered through a combination of a block and weekly attendance sessions, so that you can also develop peer support with other post-graduate ultrasound students. At the start of the course, there will be a block attendance to help orientate you within the course.</p>
