## **PROFESSOR JON YORKE**

Professor of Human Rights and Director of the Centre for Human Rights at Birmingham City University

Professor Jon Yorke is a Professor of Human Rights and he created the Centre for Human Rights at Birmingham City University in 2014. He has advised the United Nations, the European Union, and the Council of Europe, numerous human rights institutions, and civil society organisations. He regularly contributes to the Universal Periodic Review, he has filed amicus *curie* briefs in legal proceedings in national and international courts, and submitted complaints on behalf of victims of various human rights violations to the UN Special Rapporteurs and the UN Working Group on Arbitrary Detention. His scholarship focuses upon general human rights, with a specialism on the death penalty and the work of the OHCHR.



## **DR ALICE STOREY**

### Senior Lecturer in Law at Birmingham City University and Academic Lead of the UPR Project at BCU

Dr Alice Storey is a Senior Lecturer in Law and Associate Director of the Centre for Human Rights at Birmingham City University, where she leads the UPR Project at BCU. Alice's research predominantly focuses on the UN's Universal Periodic Review (UPR) mechanism and how States and civil society organisations engage with international human rights. Alice is one of three co-founders of the UPR Academic Network, which brings together an international network of scholars working on the UPR.

## **DR FATOU BENSOUDA**

### The Future of the United Nations

Her Excellency Dr Fatou Bensouda, *The Gambia High Commissioner to the United Kingdom, Former Prosecutor of the International Criminal Court (ICC) 2012-2021* 

Chair: Mr Lamin Daffeh, Lecturer in Law, Birmingham City University

Dr Fatou Bensouda served as Prosecutor of the International Criminal Court -(The ICC), 2012-2021), having assumed office in 2012. In 2011, she was elected by consensus by the Assembly of States Parties to serve in this capacity. Dr Bensouda was nominated and supported as the sole African candidate for election to the post by the African Union. She is the first woman to serve as the Prosecutor of the ICC. Her nine year mandate as ICC Prosecutor ended on 15 June 2021.

Under her leadership, Dr Bensouda has greatly reinforced the capacity of her Office through a number of strategic and managerial initiatives and expanded her Office's activities to cover 14 investigations, and countless active preliminary examinations in conflicts around the world. Through her work, she has strived to advance accountability for atrocity crimes, highlighting in particular the importance of addressing traditionally underreported crimes such as sexual and genderbased crimes, mass atrocities against and affecting children, as well as the deliberate destruction of cultural heritage within the Rome Statute framework.

In 2018, Dr Bensouda received the Bled Strategic Forum's Distinguished Partner Award for the continuous commitment an her part, and on the part of the ICC, to international peace and justice. In the same year, she was invited and

joined the eminent roster of International Gender Champions. Prior to the end of her mandate. Dr Bensouda was awarded *l'ordre national du Lion du Sénégal* by the President of Senegal for her dedicated service in the advancement of international criminal justice, and her native country, The Gambia, announced that she will honour for her principled service as ICC Prosecutor. At the end of her mandate in 2021, Dr Bensouda was awarded The Outstanding Achievement Award by The International Law Association American Branch (ABILA), and The Sapienza Human Rights Award from Sapienza university Rome, Italy. She had been chosen to receive the 2022 Prominent Woman in International Law by The American Society of International Law.

Dr Bensouda (and the Office she led as ICC Prosecutor) had been nominated for the 2021 Nobel Peace Prize in recognition of their accomplishments and work in advancing international criminal justice, without fear or favour.

Dr Bensouda currently serves as The Gambian High Commissioner to the Court of St James's and Ambassador Extraordinary and Plenipotentiary to the Kingdoms of Denmark, Norway, Sweden, the Republics of Austria, Ireland, Finland and the Vatican City.



## **MR GIANNI MAGAZZENI**

Former Chief of the UPR Branch, Office of the United Nations High Commissioner for Human Rights (OHCHR)

Gianni Magazzeni has held different responsibilities in the OHCHR, including Chief of the Human Rights Council's Universal Periodic Review Branch (2017 - 2023): Chief of the Americas. Europe, and Central Asia Branch (2010 – 2017), and Chief of the National Institutions and Regional Mechanisms Section (2010 - 2007) within the Field Operations and Technical Cooperation Division. Gianni Magazzeni served as Chief of the Human Rights Component of the UN Assistance Mission in Irag (2006 – 2007). He was

Special Assistant to the first High Commissioner for Human Rights (1994–1997) and to Heads of the human rights program since 1987. He joined the United Nations in the Department of Disarmament Affairs, in New York, in 1984. A graduate of Yale University (MA in International Relations), he had a Fellowship at the University of Bern, Switzerland, and a BA from the University of Pisa and Scuola Superiore Sant'Anna, Italy.

Gianni Magazzeni's talk at the conference will focus on the human rights aspects of the Pact for the Future and the UN's Universal Periodic Review (UPR).



Counsellor, Head of the Human Rights Team, Permanent Mission of Switzerland to the United Nations in Geneva, detached to the Office of the President of the Human Rights Council throughout 2025

Barbara Fontana holds a Bachelor and Master's in International Relations from the Graduate Institute of International Studies in Geneva and has specialised in international law. She has been working for the Federal Department of Foreign Affairs of Switzerland since 2001 and at the Permanent Mission of Switzerland to the United Nations in Geneva since 2009. She describes herself as a Human Rights Council operative. Other than the Human Rights Council as an institution and its place within the United Nations human rights system, Ms. Fontana focuses on human rights issues such as fundamental freedoms, in particular peaceful assembly and freedom of expression, transitional justice, human rights defenders, as well as the Middle East and North Africa region.

Barbara Fontana's talk will focus on human rights diplomacy at the Human Rights Council, with examples from the question of the death penalty and the promotion and protection of human rights in the context of peaceful protests resolutions.



### NICOLETTA ZAPPILE

Deputy Director, UPR Info, Geneva, Switzerland

Nicoletta joined UPR Info in July 2018 as a Programme Manager, where she leads efforts to engage a wide range of stakeholders, including human rights defenders, NGOs, and national human rights institutions (NHRIs), in the Universal Periodic Review (UPR) process to advance human rights. She oversees capacity-building activities and fosters partnerships with international organizations and universities. Before joining UPR Info, Nicoletta served as an Officer at the International Commission of Jurists and began her career at a Geneva-based media start-up specializing in international affairs. She holds a Master's in International Relations from the University of Florence and an LL.M. in International Humanitarian Law and Human Rights from the Geneva Academy of International Humanitarian Law and Human Rights.

Nicoletta Zappile's talk will focus on the opportunities and challenges of the UN's Universal Periodic Review.



## MR IMRI SCHATTNER-ORNAN

Former Consultant, Médecins Sans Frontières / Doctors Without Borders, Senior Lecturer in Humanitarian Practice at Liverpool School of Tropical Medicine

Imri is a humanitarian practitioner and an academic working on humanitarian practices. Since 2008, he has worked in various international non-governmental organisations, including the International Rescue Committee (IRC) and Médecins Sans Frontieres (MSF). Most of his humanitarian career was as a Project/Field Coordinator, directly managing relief operations in the field. He has worked in Liberia. Ethiopia, Central African Republic, Democratic Republic of Congo and Nigeria. Most of his work included managing health related operations including hospitals and primary health centres, health services in refugee camps,

response to medical emergencies include refugees' influx, and working with marginalised communities on issues such as Gender-Based Violence. He has also participated in the response to the West Africa Ebola outbreak.

Since 2016, Imri has transitioned to an academic position and is currently a Senior Lecturer in Humanitarian Practice in the Liverpool School of Tropical Medicine (LSTM), where he leads the MSc in Humanitarian Studies and a joint MSF - LSTM - University of Manchester Post-graduate programme on Humanitarian Practice (LEAP). Imri's research topics include humanitarian practice and humanitarian ethics, working in complex and authoritarian contexts and the use of games in humanitarian education.



## FRANCESCA RESTIFO

Senior Human Rights Lawyer and the UN Representative of the International Bar Association's Human Rights Institute (IBAHRI)

Francesca Restifo has extensive work experience with regional and international UN and NGO human rights systems. She worked with the UN Refugee Agency (UNHCR Regional Legal Unit for the Americas) in the field as Senior Legal worked on analysis and implementation concerning rights of refugees and asylum -seekers, Later, at UNHCR's Headquarters in Geneva, as advisor in the Division of International Protection, Francesca has expertise in advocacy with the UN Human Rights Council and the UN Human Rights System in general. She was the Deputy Executive Director and International Advocacy Director in a Geneva-based International Human Rights NGO where she led a team of lawyers and advocates. Francesca also joined the World

From 2003 until 2007 Francesca worked at the European Parliament (EP) in Brussels, as Legal and Policy Advisor for the EP Committees on Civil Liberties and Sub-Committee on Human Rights as Legal Adviser. During her professional experience Francesca travelled extensively in Africa and Latin-America to work directly with local human rights defenders, grassroots activists, affected communities, refugees, women and children, victims and survivors and bring their voices at the UN.

Francesca has a Master Degree in Law at the University "La Sapienza" (Rome, Italy) specialised in International law. She owns a specialization in Human Rights, International and European Law obtained at Katholieke Universiteit Leuven (KU Leuven, Belgium), and a LLM in Law and Economics at the Universities of Vienna (Austria) and Rotterdam (Netherlands). Francesca authored a number of articles, handbooks and publications on human rights and international law, as well as a number of UN reports and submissions. Francesca speaks fluently English, French, Spanish and Italian.

Francesca Restifo's talk will focus on the role of legal professionals in upholding the rule of law, promoting and protecting human rights and help transforming global governance.
