After their undergraduate degree, your child may decide they want to continue studying at postgraduate level, also known as a Master's degree. This may be because they want to explore their chosen subject in-depth, begin their career in academia or specialise in a certain industry or sector. We understand there can be lots of information and things to think about when it comes to your child continuing their education, so our guide explains it all.

UNDERSTANDING POSTGRADUATE STUDY

There are different types of Master's degrees which relate to the area of study the subject sits under. For example, the qualification obtained after studying a Master's in Fine Art is a Master of Art. The different types of qualification include:

- Master's of Arts (MA)
- Master's of Science (MSc)
- Master's of Philosophy (MPhil)
- Master's of Engineering (MEng)
- Master's of Architecture (MArch)
- Master's of Research (MRes)*

Postgraduate applications are accepted throughout the year and are submitted direct to the university.

WHY STUDY A POSTGRADUATE DEGREE?

1. EMPLOYABILITY

There are an increasing number of occupations where employers **require a postgraduate qualification**, including some areas of law, engineering and teaching, professional psychology roles, international development and NGOs, technical roles in the environment profession and roles in investment banking.

2. BUILD CONNECTIONS

Studying at postgraduate level gives students an opportunity to develop professional networks with industries in Birmingham and the rest of the UK. Our STEAMhouse business innovation centre provides students with access to industry links, placement opportunities and talks from business experts.

3. EARN MORE

Someone with a Master's degree or PhD earns **£6,000 more per year, or £240,000 over a 40-year working life**, than someone with an undergraduate degree.

4. PASSION

Postgraduate study will allow your child to explore their chosen subject in depth.

Our contemporary, flexible courses with practice-based learning and international opportunities allow them to develop their knowledge and become experts in their field.

5. LEARN FROM THE EXPERTS

Postgraduate students are taught by experienced researchers who are focused on advancing their area of research and will help your child to master your subject. 93% of our research was recognised internationally for originality, significance and rigour, of which 19% was judged world-leading (REF 2021). Many of our staff maintain links with industry and will be there every step of the way to help postgraduate students establish their own careers.



STUDENT FINANCE

Studying a postgraduate qualification is a significant investment into your child's future, but loans and financial support are still available to help with course and living costs at postgraduate level.

Postgraduate students starting their course in 2023 will be able to apply for up to £11,836 to cover the cost of their tuition and their living costs. Unlike the undergraduate student loan, this loan is not based on household income and your child will be able to apply for as much as they think they will need to fund their studies. Alternatively, some postgraduate students choose to self-fund.

Postgraduate students are responsible for paying their tuition fees direct to the university, meaning that budgeting their money will be a key skill as a postgraduate student.

Each year, there are a range of additional scholarships, loans and bursaries offered by external organisations that are available to those pursuing postgraduate study. These could be companies or charities wanting to encourage study in a particular area or from the universities themselves.

Lots of postgraduate students choose to supplement their student loan with work. Both part-time and full-time postgraduate study are popular options:

Full-time study	Part-time study

An intensive year of learning	Learning is spread out over two years
Time to get a part time job to supplement income	Time to work in full-time employment to supplement income

EMPLOYABILITY

There are an increasing number of occupations where employers require a postgraduate qualification, and even if they're not a necessity, postgraduate degrees are still valued by many companies.

At postgraduate level, students develop several key skills vital to working in industry or completing further study such as time management, problem solving and critical thinking.

Based at our expanding City Centre Campus, this state-of-the-art centre will enable our students to share their ideas with industry and work on real, industry-based projects, as well as provide access to outstanding facilities and equipment and opportunities to network with local businesses. STEAMhouse is also the perfect springboard for a student to launch their own business.

ACCOMMODATION

As a postgraduate student, your child will still be able to apply for university accommodation. During the application process, they will be able to list their preferences to ensure they can find the best fit for them.

We have a range of student accommodation residences which all offer full kitchen facilities, WiFi, furnished rooms, a maintenance service, laundry facilities and 24-hour CCTV. Plus, all of our accommodation is within easy distance of our campuses and Birmingham city centre and its transport links.

Costs range from £125 - £200 per week (2023). All bills are included in the weekly fee, so there is no need for new students to worry about budgeting for these during their stay. Rooms are subject to availability.
