<b>6</b>	<b>Module Overview</b>
<p>This module is predominantly designed for healthcare practitioners who wish to expand their knowledge, skills, and Professional Development in Clinical Leadership in Cancer Care.</p> <p>It is vital that those who work with patients with cancer are supported with appropriate education and reflective practice, to drive up the quality of care for these patients. This module provides you with the opportunity to develop the core leadership skills and behaviours to care for people affected by cancer, and to provide underpinning cancer knowledge for the workforce.</p> <p>This module can also be studied as a standalone module. This module is delivered completely online incorporating course teaching material and a variety of learning activities, such as online lectures, forums, quizzes and workshops. You are expected to participate and engage with the module material which is available on the module MOODLE site. The module assessment is an in-person presentation. Tutorial support will be offered via video tutorials, chat forums, email and telephone.</p> <p>This module aligns with the Professional Practice Programme philosophy and is designed to be flexible, and practice led. You will have the opportunity to develop skills of enquiry, reflection and problem solving. A blended learning approach is taken in line with the university's learning and teaching strategy.
