6	Course Description			
	The part time course for examination of the newborn is delivered over 20 weeks and prepares			
	midwives, nurses, and specialist community public health nurses to undertake a holistic			
	examination of the newborn and infant. This includes Public Health England (PHE, 2019)			
	requirements to become a Newborn and Infant Physical Examination Screening (NIPE)			
	Practitioner. The course is part time and is offered at level 6.			
	What's covered in the course?			
	You will learn about the normal fetal, newborn and infant development and function of the body			
	systems in order that you can then identify deviations from normal parameters. The NICE			
	postnatal guideline (NICE, 2006, updated 2015) requires continued care and monitoring of the			
	infant during the postnatal period and this module will also include complex conditions of the			
	newborn infant. You will consider how maternal, family and environmental factors contribute to			
	fetal and infant development. You will be able to identify variations from normal development,			
	considering how they occur and how they manifest. You will be prepared to practice			
	autonomously, whilst recognising when there is a need to refer to the multidisciplinary team.			
	You will consider communication with parents and families as well as to support them where			
	health promotion opportunities arise. The PHE (2019) screening programme requirements			
	include screening of heart, hips, eyes and testes and these will be explored in detail so that you			
	are prepared to take on the role of NIPE practitioner and be competent to refer appropriately as			
	per PHE requirements (PHE, 2019).			
	The theoretical component of the course is delivered at BCU, whilst you need to organise the			

practical component to ensure you have the opportunity to complete a minimum of 20 assessed



holistic examinations of the newborn. You may find there are local determined numbers of assessments required before you can practice independently on qualification. PHE (2019) stipulate that you will need to work with an appropriately qualified practitioner who is competent to undertake all elements of the PHE screening pathway. This will be a midwife, nurse or health visitor who has successfully completed a university accredited "examination of the newborn" programme of study or be a doctor (paediatrician/neonatologist or GP). They will assess your practice using a locally agreed competencies as per PHE (2019) requirements.

You will need to ensure you acquire and maintain a current evidence base to support practice, and you should be conversant with national and local guidance, procedures and priorities.

On successful completion of the course, you will be awarded 40 credits at level 6 and in addition, you will receive a Certificate in Examination of the Newborn (theory and practical components). This will allow you to work as a NIPE practitioner in accordance with locally agreed policies and procedures within the clinical area.
