It should be noted that University Partners may request a substantial payment prior to arrival in the accommodation (pre check in amount), as well as a security deposit or advance payment. Please be aware these amounts are payable before you receive Student Finance. Therefore once you are allocated a room, before you agree to any terms you should ensure that you carefully read through the contract and take note of the payment terms. Please take this into consideration when choosing your accommodation preferences.
