Postgraduate researcher focus groups

Content of the Activity:

We aim to carry out 5 focus groups with PGRs (one in each Faculty at Birmingham City University, plus a pilot) to gather data on current postgraduate researcher views on, and experiences of, applying for a doctoral degree at BCU, including how the process could be made fairer and more inclusive.

Design:

Facilitation Plan: Describe the planned approach for facilitating the fieldwork, including a structure (e.g., introductions, question themes and prompts, role of the moderator and any physical or virtual prompts or stimuli to be used).

There will be 5 focus groups: one pilot group and 4 additional groups, one per Faculty. We are hoping to recruit 4-8 participants each. They will be facilitated by members of the Routes-in Action Research Team. The structure will begin with introductions and then move into the main questions. These will be based around the following themes:

- » Perceptions/expectations of doctoral (PhD, Ed.D, DBA) study
- » Experiences of the application process, including contact with supervisors
- » Experiences of induction and starting the doctoral (PhD, Ed.D. DBA) degree
- » Recommendations about an inclusive application process

There are no external stimuli or prompts.

Questions are likely to include:

Application:

- » How did you become interested in doing a doctorate?
- » When you think of a doctoral student, what do you think of?
 - Would they look like you?
 - If they didn't, would that be a deterrent to applying?
- » Why did you apply to Birmingham City University (BCU)?
- » Talk to us about your experience of applying to Birmingham City University.
- » Did you apply to other universities? If so, what was the experience like?
- » How easy/difficult was it to find out about the opportunities offered by Birmingham City University?
- » What are you expecting in terms of opportunities Birmingham City University can offer?
- » How was your experience of contacting a potential supervisor?
 - Did you find it easy/difficult to identify someone?
 - Were you able to find a supervisor who aligns with your subject area and/or geographical area of study?
 - If not did this influence your area of study?
- » How was your experience of the application process?
- » Were there aspects of the process that you found more supportive or less supportive?

Facilitation Plan continued:

<u>Funding</u>

Did you apply for funding [e.g., M4C or other scholarships]?

- » How was the experience?
- » If you're self-funding how does that impact how you engage with your research, time allocation, pressure to complete etc?

Starting/induction

- » Talk about your experience of starting the doctorate.
- » How did you find the process of starting at Birmingham City University and being part of the doctoral community?
- » What makes you feel the most at home?

Recommendations

- » What advice would you give to someone who wants to do a doctorate?
- » In an ideal world, what would a genuinely inclusive doctoral admissions process look like? Describe it as though you were telling a story about someone applying, being accepted and starting on a doctorate.

Duration:

The focus groups will be 90 minutes. We aim to carry these out in April and early May 2024.

Delivery Information:

The focus groups will be online (Microsoft Teams), face-to-face or hybrid depending on participant preferences (identified in the pre-recruitment survey) and facilitator availability.
