

## Examples of relevant work experience might include working/volunteering for:

- A Youth Offending Team
- The Probation Service
- A drugs agency, such as Cranstoun or Right Start
- West Midlands Police Special Constabulary
- British Transport Police
- A prison, such as shadowing the resettlement team at HMP Onley
- The Independent Monitoring Board
- Victims support services, such as Emerge, Childline, or The Glade
- The Witness Service
- Mentoring services, such as The New Bridge Foundation, Circles UK, or Change Grow Live
- A housing organisation, such as Midland Heart or Fry Housing Trust
- A youth centre, such as Pump Youth, Base 25, or Kinetic Youth
- Criminal Justice arts-based charities, such as The Geese or Recre8



"New Bridge befrienders are the only form of outside contact for many people in prison. During my work experience, I gathered together responses from evaluation forms - filled out by people in prison - into a database that will be used for New Bridge's Annual Report. This placement has helped me to gain a better understanding of the emotions people face whilst in prison, and what has caused them. It has reinforced my passion for helping people in prison settings."

## Top tips for finding work experience

- 1. Start by thinking about what you are passionate about.
- 2. Network. Network. Network.
- 3. Apply early. Interviews and training are required by most organisations.
- Make sure that you align yourself to the aims of the organisation in your application.
- Don't be afraid to send speculative cover letters to organisations where roles are not advertised.
- 6. Apply to lots of different places and be open to trying something new.
